Information on annual family income and race is required to determine eligibility for public services funded with federal Community Development Block Grant (CDBG) funds. INCOME is defined as the total annual gross income of all family and non-family members 18+ years old living within the household. All sources of income must be counted from all persons in the household based on anticipated income expected within the next 12 months.
